HKSAR Government Scholarship

Regulations

- 1. The Scholarship(s) aims to reward outstanding full-time UGC-funded local / non-local undergraduate students for covering their CityU tuition fees.
- 2. In the year 2019/20, full-time UGC-funded local and non-local undergraduate students^{#^} who have achieved a CGPA* at 3.7 or above by the end of Semester B of the year 2018/19, or top seven students (in terms of CGPA by the end of Semester B of the year 2018/19) in each College / School are eligible for the scholarships.

(<u>Note</u>: According to the regulations set by the HKSAR Government, the awardees of the HKSAR Targeted Scholarship/ Belt & Road Scholarship/ Endeavour Merit Award are not eligible to receive other government scholarships (except Talent Development Scholarship / Reaching Out Award) under the HKSAR Government Scholarship Fund.)

- 3. The selection criteria are as follows:
 - Excellent performance in academic studies
 - Recognized contribution to the institution/society
 - Demonstrated leadership and good communication skills; and/or
 - Strong commitment to the Hong Kong community
- 4. The number of scholarship(s) is unfixed, subject to the funding available. The distribution of the awards amongst College/School shall be based on its student population.
- 5. The value of scholarship(s) shall be HK\$40,000 for local UGC-funded degree students and HK\$80,000 for non-local UGC-funded degree students.
- 6. The Scholarship is renewable until the completion of normal duration of the same undergraduate programme as enrolled by the recipient. The Scholarship shall be renewed in the following year, i.e. 2020/21, for those scholarship recipients who have achieved a CGPA at 3.5 or above by the end of Semester B 2019/20 and shall maintain active student status and eligible enrolment status[#] in 2020/21.
- 7. Nomination(s) from respective College/School shall reach the Student Development Services by early December 2019 and the award shall be made as soon as the Government has approved the concerned nominations.

<u>Remark</u>:

- [#] Students who are taking leave of absence in particular semester/year are **not** eligible for the scholarships.
- [^] Students pursuing Joint Bachelor's Degree program are <u>not</u> eligible to receive the HKSAR Government Scholarship.
- * The GPA for summer term 2019 will not be included, which shall be counted in the following year.

With an objective to nurture our students and to promote caring culture, the Community Relations Committee of the University Council has recommended that each award recipient is expected to make an annual donation of at least HK\$200 to City University of Hong Kong for student support via CityU Alumni Giving Club when they are in employment after graduation. This term has been incorporated into all scholarship/prize/award/bursary schemes, whether they are donated by external donors or contributed by University funding, with effect from February 2008.
