HKSAR Government Scholarship

Regulations

- 1. The Scholarship(s) aims to reward outstanding full-time UGC-funded local / non-local undergraduate students for covering their tuition fees.
- 2. In the year 2016/17, full-time UGC-funded local and non-local undergraduate students[#] who have achieved a CGPA* at 3.7 or above by the end of Semester B of the year 2015/16, or top seven students (in terms of CGPA by the end of Semester B of the year 2015/16) in each College / School are eligible for the scholarships.

(Note: In case the nominees are receiving an entrance scholarship in the current academic year, they will be granted an additional sum to top up their scholarship to HK\$40,000 (for local students) / HK\$80,000 (for non-local students). Nevertheless, students are not allowed to receive the amount of both Government Scholarship and CityU Entrance Scholarship concurrently.)

- 3. The selection criteria are as follows:
 - Excellent performance in academic studies
 - Recognized contribution to the institution/society
 - Demonstrated leadership and good communication skills; and/or
 - Strong commitment to the Hong Kong community
- 4. The number of scholarship(s) is unfixed, subject to the funding available. The distribution of the awards amongst College/School shall be based on its student population.
- 5. The value of scholarship(s) shall be HK\$40,000 for local UGC-funded degree students and HK\$80,000 for non-local UGC-funded degree students.
- 6. The Scholarship is renewable until the completion of normal duration of the same undergraduate programme as enrolled by the recipient. The Scholarship shall be renewed in the following year, i.e. 2017/18, for those scholarship recipients who have achieved a CGPA at 3.5 or above by the end of Semester B 2016/17 and shall maintain active student status and eligible enrolment status[#] in 2017/18.
- 7. Nomination(s) from respective College/School shall reach the Student Development Services by mid-November 2016 and the award shall be made as soon as the Government has approved the concerned nominations.

Remark:

With an objective to nurture our students and to promote caring culture, the Community Relations Committee of the University Council has recommended that each award recipient is expected to make an annual donation of at least HK\$200 to City University of Hong Kong for student support via CityU Alumni Giving Club when they are in employment after graduation. This term has been incorporated into all scholarship/prize/award/bursary schemes, whether they are donated by external donors or contributed by University funding, with effect from February 2008.

[#] Students who are taking leave of absence in particular semester/year are not eligible for the scholarships.

CityU Scholarship

Regulations

The establishment of CityU Scholarship aims to reward those local / non-local students who have achieved outstanding academic performance and/or contribution to the University but are not benefitted under the University's Entrance Scholarship Scheme or HKSAR Government Scholarship Scheme. The following regulations shall apply as of 2016/17:

- 1. Full-time UGC-funded local and non-local undergraduate students[#] who:
 - (i) have achieved a CGPA* at 3.7 or above by the end of Semester B of the year 2015/16, or top seven students (in terms of CGPA by the end of Semester B of the year 2015/16) in each College / School; and
 - (ii) are not benefitted under University's Entrance Scholarship Scheme or HKSAR Government Scholarship (SFA no. 547) are eligible to compete for the CityU scholarships.
- 2. The selection criteria are as follows:
 - Excellent performance in academic studies
 - Recognized contribution to the institution/society
 - Demonstrated leadership and good communication skills; and/or
 - Strong commitment to the Hong Kong community
- 3. The number of scholarship(s) is unfixed, subject to the funding available. The distribution of the awards amongst College/School shall be based on its student population.
- 4. The value of scholarship(s) shall be HK\$40,000@ for covering tuition fees of the student.
- 5. The Scholarship is renewable until the completion of normal duration of the same undergraduate programme as enrolled by the recipient. The Scholarship shall be renewed in the following academic year, i.e. 2017/18 for those scholarship recipients who have achieved a CGPA at 3.5 or above by the end of Semester B 2016/17 and shall maintain active student status and eligible enrolment status# in 2017/18.
- 6. Nomination(s) from respective College/School shall reach the Student Development Services by mid-November 2016 and the award shall be made as soon as the endorsement has been sought.

<u>Remark:</u>
