# Terms & Conditions of Participation

The captioned research activity takes place in City University of Hong Kong, HK SAR, China, is a part of a joint research study on the mobility of human cancer cells on patterned substrates by Dr. Yun-Wah LAM of the Department of Biology & Chemistry and Prof. Stella W. PANG of the Department of Electronic Engineering of City University of Hong Kong.

### Role of the participant

Participation in this research activity is voluntary. By taking part in this research activity, the participant uses an open-source image analyzing software to track the movement of selected human cancer cells in a series of time-lapse movie frames. The tracking data will be collected and further analyzed in order to study the mobility and behavior of human cancer cells on various patterned substrates. This research activity takes place on 11 October 2014.

### Ownership of data

The ownership of all the tracking data provided by the participant is transferred to Dr. Yun-Wah LAM and Prof. Stella W. PANG of City University of Hong Kong for uses in scientific journals and books, public talks, seminars, lectures, exhibitions, research grant proposals, and any other purposes seem appropriate by Dr. Yun-Wah LAM, Prof. Stella W. PANG and City University of Hong Kong.
